Positioning of Pergola:

1. To ensure there is adequate space for their Pergola to be installed.

We recommend a minimum of a 2ft gap around the whole structure to allow ease of installation.

• We confirm there is at least a 2ft gap around the installation area.

2. Ground Preparation:

Please ensure the ground is flat, level, and solid for the construction of the Pergola.

3. Base Type for Bolting Down:

- On the day of installation, and if satisfied, you will be required to sign off all works carried out. The installer will take images of carried out works on completion to confirm the quality of the work done.
- Please note that at the commencement of installation, the Consumer Protection Act (Distant Selling Regulations 2000) will no longer apply.
